## OKLAHOMA DEPARTMENT OF ENVIRONMENTAL QUALITY NOTICE – DRAFT PERMIT

The Oklahoma Department of Environmental Quality (DEQ) has received an application for a Tier III solid waste Permit Modification to increase the permit boundary of Northeast Construction and Demolition (C&D) Landfill from 90.1 acres to 163.3 acres. Northeast C&D Landfill is located at 2601 N. Midwest Boulevard, Spencer, Oklahoma. A legal description of the property is provided with this Notice. The application was filed by N.E. Land Fill, LLC (a subsidiary of WCA of Oklahoma, LLC, a GFL Environmental [GFL] Company), on August 29, 2023.

DEQ has tentatively found that the application meets the requirements of Title 27A of the Oklahoma Statutes, Section 2-1-101, *et seq.*, Section 2-10-101, *et seq.*, and DEQ's rules found at Oklahoma Administrative Code (OAC), Title 252, Chapters 4 and 515, and has prepared a draft permit for public review.

The permit application proposes to increase the permit boundary from 90.1 acres to 163.3 acres, an increase in waste disposal area from 67.7 acres to 121.2 acres, a new total design capacity of 10,505,939 cubic yards. Facility operations will continue in the same manner as currently being conducted at the existing facility. The average volume of C&D waste received daily at the facility is not anticipated to increase as a result of this permit modification.

Also, any person may request, in writing, a formal public meeting to present written or oral statements and data concerning the draft permit. A request for a public meeting must identify the nature of the issues to be raised in the meeting. If DEQ determines, based on the requests it receives, that there is a significant degree of public interest in the draft permit, it will schedule a public meeting and provide notice of the date, time and place.
